How do I open a support case?

Clients may come into Domestic Relations daily between the hours of 8:00AM and 3:30PM. Upon arrival, the client is given an Intake Questionnaire to complete which asks for information on all parties in the support case. You may also call our office at the above number and the form can be mailed to you or you can access our website at the link above to download the form and have it completed prior to arriving to our office. The interview process takes about 1 hour per case. All clients are seen on a first come. first serve basis. Clients are encouraged to come in as early in the morning as possible. It is recommended that you come before 12:00p.m. If you come after 12p.m. there is no guarantee that you will be seen that day. The longest wait times are experienced over the lunch hours. (i.e. 11:30a.m. to 1:30p.m.).



What do I need?

Please bring the following information along for yourself and any children you will be filing for when you come to open your support action. Domestic Relations will not acquire this information for you. Providing this information may expedite the processing of your case.

□ Driver's License or photo identification

□ Social Security cards for yourself and all children you are filing for

□ Birth certificates for all children you are filing for

□ Paternity order or acknowledgement of paternity for children, if one already exists

□ Marriage License

□ Divorce filing or divorce decree

□ Medical insurance cards

□ Family Court documents of any kind (support order, visitation order, custody order, divorce, protection from abuse, etc) The following information is needed for the person you are filing against:

- \Box Complete name
- \Box Date of birth
- □ Social Security number
- □ Address
- □ Employer
- □ Place of birth
- Parents names and addresses

□ A friend or contact person's name address and phone number

□ Disability, pension, or any other type of income information

□ Asset information such as real estate, vehicles, and bank accounts

□ The name and address of any organizations the party may belong to

□ The name of any law enforcement agencies the party has had contact with including prisons, and the approximate date of that contact.

□ A photo of the party Where can I get it?
