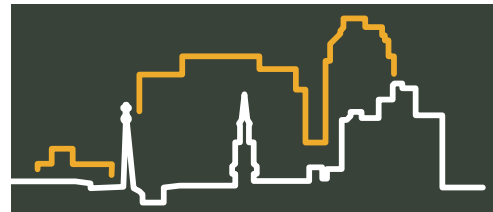

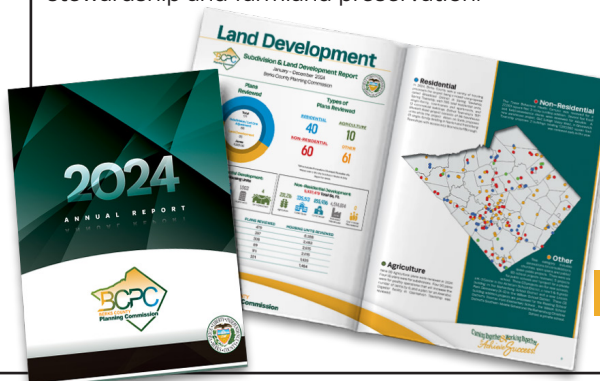
## BERKS COUNTY COMPREHENSIVE PLAN

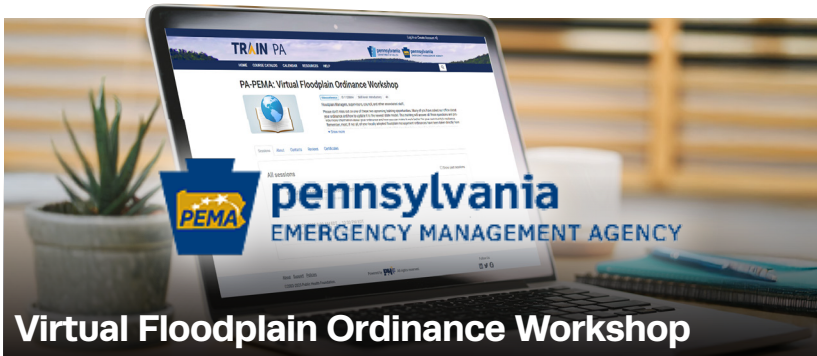
