

New Construction, Replacement or Modification of Existing Ag Structure

BCALP Guidelines state:

Construction or modification of an agricultural building can occur anywhere on the farm after BCALP Board acknowledgement.

- ♦ The construction or use of any building or other structure for agricultural production or a commercial equine activity is permitted.
 - ♦ The erection of fences for agricultural production or a commercial equine activity and protection of watercourses such as lakes, streams, springs, and reservoirs is permitted.
 - ♦ Agriculture structures should be located in areas that remove the least productive and the least amount of agriculture land.

Required Steps

- ⇒ Request Easement Modification Form be mailed or emailed.
- ⇒ Use the enclosed aerial photo to identify the location of the proposed structure.
- ⇒ Provide Municipal acknowledgement and/or approval or explanation of status.
- ⇒ Complete the Easement Modification Form in detail
- ⇒ Confirm all ACE Farm Owners sign and date the Easement Modification Form
- ⇒ Submit the Easement Modification Form with drawings and supporting documents including a copy of the current Conservation Plan to the Berks County Department of Agriculture office for review and BCALP Board acknowledgement. Submissions can be mailed, dropped off in the office, or E-mailed to DeptofAg@BerksPA.gov
- ⇒ If building for animal housing also provide: *(check when included)*
 - _____ A copy of Land Development Plan Drawings
 - _____ A copy of Manure or Nutrient Management Plans
 - _____ A copy of updated Conservation Plan if developed or required by Township.

Construction should not begin before a letter of approval is received from the
BCALP Board.
