Official Municipal Election Ballot

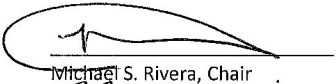

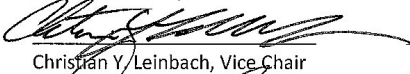

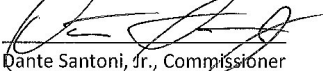
