# BERKS COUNTY PRISON BOARD MINUTES FEBRUARY 14, 2024

#### **APPROVAL OF MINUTES**

#### **JAIL SENIOR STAFF REPORTS**

INMATE POPULATION: Warden Jeffrey Smith stated the inmate population is 743. There are 5 inveniles at Wayne County and 1 juvenile at Lehigh County.

Year to date the average population is 780 inmates. There is 463 total commitments and 476 discharges.

There are 37 inmates sentenced to an SCI. Eleven are ready to be transported between now and February 27<sup>th</sup>. Twenty-six inmates are awaiting a transport date.

PROJECT UPDATES: Warden Smith updated the board on the current projects:

- The rear dormers were repaired on the mansion. Working on obtaining window replacements and painting quotes.
- Working with the vendor to replace the yard doors on housing units.
- Working on obtaining quotes for additional fenced recreation yards.
- Additional stainless steel shower inserts were installed on 2 more housing units.
- Parking lot paving, widening, and sealing project is going out to bid.

STAFFING: Deputy Warden Roberts updated the Board on the status of the staffing:

- 23 Correctional Officer vacancies
- 6 Sergeant vacancies
- 12 new candidates in the academy with a tentative graduation date of April 15<sup>th</sup>
- Correctional Officer testing was held on February 15th.

PROGRAMS: Warden Smith updated the Board on the mental health roster. There are currently 122 D roster inmates in custody. There are 396 C roster inmates in custody. There were 6 inmates eligible for work release in the month of January. At the end of January there was 30 trustee classified inmates. Those inmates, after jail review are determined to be eligible for work release and eligible to work on the grounds.

#### SOLICITOR'S REPORT

County Solicitor Christine Sadler has nothing to report in regular session. There are 2 updates for executive session with no action needed.
