Commissioners' Board Meeting November 6, 2008

The Berks County Board of Commissioners met in regular session on Thursday, November 6, 2008 at 10:30 A.M. in the Board meeting room on the thirteenth floor of the Berks County Services Center, pursuant to due notice to Board members and the public.

Commissioner Chair Mark C. Scott called the meeting to order with Commissioner Christian Leinbach and Commissioner Kevin Barnhardt in attendance. Also present were the Chief Clerk Terry L. Styer, County Solicitor Alan Miller, Esq. and County Administrator William E. Dennis.

Commissioner Scott opened the meeting with a moment of silence and Pledge of Allegiance to the Flag.

Presentation

Commissioner Barnhardt presented the Hall of Heroes website address at http://www.berksheroes.com, which he said is slated to be unveiled on Veterans' Day, November 11, 2008, and intended to permanently honor the loss of the brave men and women of Berks County who laid down their lives to defend our liberty and freedom. For the work involved in pulling this project together Commissioner Barnhardt thanked the county staff and U.S. Air Force Master Sergeant (retired) Larry Cohen; US Army 1st Sergeant (retired) Lee Mancias and Specialist 4th Class (retired) Diane Price, all of whom were members of this Berks County Veterans Task Force.

Commissioner Leinbach then introduced and encouraged citizen donations to the Keystone Soldiers – www.keystonesoldiers.com, a 100% volunteer non profit organization providing support for our soldiers as they are deployed on foreign lands.

Scott Gruber from National Penn and Dick Ehst from Sovereign Bank attended the meeting to continue discussions from last week regarding the Treasurer and Controller's request to move County's operating accounts to a new bank better able to handle online transactions and the assurance of an accurate interface with the County's Oracle Financial system. Commissioner Leinbach discussed what he believed may have been lacking in the comparative analyses of the two bank's on-line services and suggested that more detailed comparable information should be gathered prior to making a recommendation to the Commissioners for this selection. The Commissioners requested the Solicitor to develop whatever authorizing actions are necessary to complete this transaction for the November 13th Commissioners' meeting.

Commissioner Barnhardt made a motion that was seconded by Commissioner Leinbach to approve the October 28, 2008 Commissioner workshop and the October 30, 2008 Commissioners meeting minutes, all voted yes to approve.
