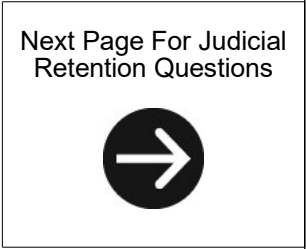

Official Municipal Election Ballot

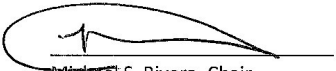

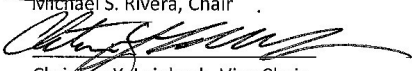

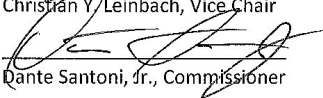
