

In accordance with Federal Highway Administration Regulation 23 CFR 200.9, and Title 49 CFR, Department of Transportation, Subtitle A, Office of the Secretary Part 21, and FTA Circular 4702.IB the MPO has developed procedures for prompt processing and disposition of the Title VI complaints. Any person believing the MPO has violated Title VI in the administration of its programs or activities may file a complaint with the MPO's Title VI Compliance Officer by telephone, fax, or in writing at the contacts shown above, or by email at planning@countyofberks.com. Purpose of this Report

In accordance with the Fixing America's Surface Transportation (FAST Act) legislation, this document will identify the projects that received obligated federal funding during the Federal Fiscal Year (FFY) October 1, 2017 to September 30, 2018. The Federal Highway Administration defines 'obligated' as "the Federal government's promise to pay a State for the Federal share of a project's eligible cost." These funds are typically a portion of the overall project cost. The overall funded project cost generally consists of Federal funds and funds matched from other sources, typically obtained by the State or local project sponsor. In some instances, the obligated funds for a project become deobligated as a result of lower than expected costs, project removal or withdrawl, and other factors. The FHWA defines 'deobligation' as "the downward adjustment or cancellation and removal of a previously recorded Federal fund obligation associated with a project." The deobligated funds are then reapportioned to other projects. Deobligation amounts in all tables throughout this document are identified in red and parentheses.

Figures included in this report only apply federal dollars to referenced projects. Projects may also include state and/or local funding that is not reflected in project totals.

As an outgrowth of developing the statewide financial guidance during the FFY 2007 Program update, an Interstate Management Program was recommended and eventually agreed to by the planning partners. This program is centrally managed by PennDOT and sets aside annual funding to address statewide Interstate highway and bridge projects. Interstate Management Program funds assigned to a region are separate and in addition to those used in developing the regional TIP.

The FFY 2018 Transit Annual List of Obligated Projects table is located at the end of this document.

Reading Area Transportation Study MPO

The Reading Area Transportation Study (RATS) Coordinating Committee is the designated Metropolitan Planning Organization (MPO) for transportation in Berks County. RATS facilitates the regional, performance based planning process that serves as the basis for spending state and federal transportation funds for improvements to streets, highways, bridges, public transit, bicycle and pedestrian networks allocated to Berks County. RATS is currently responsible for prioritizing approximately \$85 million annually to advance transportation improvement projects throughout the county.

To receive federal funding, transportation projects must be identified in the Long Range Transportation Plan (LRTP). The LRTP examines socioeconomic trends that affect travel, the current state of the county transportation network, and describes multimodal transportation strategies to address identified transportation needs. The plan outlines the region's long-range transportation vision and projects the transportation needs of the county through the year 2040. The plan must be updated every four years and must project at least 20 years into the future to meet federal requirements.

RATS also approves the Transportation Improvement Program (TIP) which is the capital-funding program that contains all surface transportation projects eligible for federal funding that are programmed for implementation over the next four years. Projects scheduled in the TIP were first identified in the LRTP as projects that would impact transportation needs in the county. The most recently adopted TIP (FFY

2019-2022, approved July 29, 2018) was approved by FHWA/FTA on September 25, 2018. The TIP lists 135 projects totaling \$342,273,833 for highway, bridge, and transit projects over the four year period from 2019 to 2022.

In addition to the material included in the TIP, PennDOT created an internet-based mapping tool that allows interested parties to view the projects included in the TIP and to obtain more information about a proposed project. Users may zoom in or out to view project locations. Clicking on the link project provides a pop-up screen giving project specific information. To view the most recent TIP for Berks County, select the Area of Interest as Berks County. Select Planning for the Category. Finally, choose TIP Map as the Map Template.

Public Involvement

RATS continually strives to actively engage public participation in every aspect possible of the transportation planning process. In July, 2017, RATS adopted a Public Participation Plan that details strategies and procedures to ensure specific opportunities exist for the public to offer input and provide feedback as active participants in the decision-making process. RATS uses a wide range of methods and media to enhance the public's participation in the process.




The pie chart and table below show the obligation amounts and the number of projects funded for Federal Fiscal Years 2014-2018.

Summary of Obligated Funds by Fund Class




The majority of obligated funds went to construction projects in FFY 2018. Funds were deobligated from Final Design and Utility phases.
