Damage to Rented Premises (Each Occurrence): \$1,000,000

Medical Expenses (Any One Person): \$10,000

Personal Injury: \$1,000,000

General Aggregate: \$2,000,000

Products - Comp/Op Aggregate: \$2,000,000
