**CHECKS MADE PAYABLE TO “PROTHONOTARY OF BERKS COUNTY”**

*All checks returned for insufficient funds will be assessed a \$30.00 service charge.*

\*If you are presenting filings for more than one case in the same mailing, the Prothonotary requests a separate check for the filing fees for each case.

\*If a claim for custody, partial custody or visitation is asserted in a divorce complaint or in a subsequent pleading, it shall contain the information required by PA. R.C.P.1915.15. An additional filing fee of \$15.00 shall be required per local rule 1920.31(a)(1)(c), plus **\$10.00 ACT 119 FEE [Jen and Dave]** and \$5.00 PAF fee for a total of **\$30.00**.

\*The maximum fee to be charged a political subdivision for any one of the services provided for herein shall be \$10.00 (42 P.S. §21075), and if applicable a \$5.00 PAF fee, a \$13.00 satisfaction fee, a \$40.25 JCP fee and tax.
