Hazmat Team Report

Phil Salamone reported in absentia that there have been 4 spill trailer responses since 12/11. Trailers will be replaced over the next few years. The team has received its new particle meter and will be utilized at the next training. We will be replacing our hazmat suits as the previous company abruptly went out of business last year. 2 new team members earned their Hazmat Ops and a third member will join them in an upcoming hazmat tech course.

The team completed Tech-MERRTT training on Saturday, February 3rd. Some team members will participate in a rail disaster tabletop exercise in June. A riverboom exercise with DEP is being planned for this summer, date TBD. We will be running a HAZCAT class for the team in September.

Meg Young-Kraft asked the body to review and comment on the current Off-Site Emergency Operation Plan format and template content. A plan from the test facility in the Tier II Manager was created and distributed to members for their review and input. Rich Tornielli suggested placing the ERG guide number of each chemical in the hazard analysis for easier and quicker reference. Alex Melendez suggested adding fields to the personnel/resource section identifying CPR/First Aid certified staff and on-site chemical experts. Harry Adams reminded the body having an emergency plan is an OSHA requirement, perhaps there is a way to better integrate the two to help facilities be compliant in both. Gary Moulder suggested some language in the plan should be made more clear or have explanations embedded. Meg will be taking these suggestions to the website developer to make changes at the next update. Any more suggestions should be sent to Meg via email for discussion at the next meeting.

 While she was unable to crunch and compare numbers from last reporting year to this one, Meg stated her subjective observation of submissions so far indicates a higher compliance in plan submittals than previously.
