3. <u>Discussion and potential action regarding candidate eligibility concerns, including the following races.</u>

Mr. Kauffman provided an overview to the Board of various candidate eligibility concerns that were raised during this past election cycle along with a summary of the law as it relates to candidate eligibility and the Board's statutory duties to successful candidates, as set forth in the Election Code. Mr. Kauffman recommended that that there isn't any further action for the Board to take concerning the Bethel Township Tax Collector and Lyons Borough Council candidate eligibility complaints. Mr. Kauffman stated that, at this point, these are issues to be decided by the local municipality, as these candidates will be issued a certificate of election, consistent with the Election Board's statutory duties. Regarding the Reading 18-1 Judge of Election issue, Mr. Kauffman believes that there is an amicable resolution in place but will provide an update to the Board at a future meeting. The Board asked questions and made comments on the matter.

4. Authorize Execution of the Following:

- a. On the motion of Commissioner Leinbach, seconded by Commissioner Santoni, the Board authorized the execution of the votes cast for state-wide offices from the November 4, 2025, Municipal Election to the Department of State.
- b. On the motion of Commissioner Santoni, seconded by Commissioner Leinbach, the Board authorized the certification of the official results of votes cast during the Municipal Election held on November 4, 2025.

ELECTION DIRECTOR'S REPORT

Ms. Norton shared that the 2% percent audit has been completed this week. She noted that it was a combination of hand count and machine count due to time constraints. Election Services will begin issuing Certificates of Election to the winners after the meeting.
